Prior to initiating your qualification with the Division of Oil and Gas, all entities transacting business in this state must register with the Department of Commerce, Community and Economic Development. Please contact [Department of Commerce, Community and Economic Development](#) or 907-465-2550 for information concerning registration, forms, and fees. The Division is responsible for monitoring and implementing oil and gas acreage limitations which apply to all acreage whether it is held or controlled, directly or indirectly by qualified individuals and entities (AS 38.05.140(c) and 11 AAC 82.300 – 310).

When do I need to qualify and for which Division of Oil and Gas programs must my company be qualified?

- o All entities must submit an initial qualification packet, as outlined in this document, prior to:
 - Submission of a bid in an oil and gas or geothermal lease sale
 - Submission of an application for an exploration license
 - Submission of an application for assignment of working interest or initial separation of overriding royalty interest in an oil and gas lease, geothermal lease, oil and / or gas exploration license
 - All entities must maintain a current qualification status to hold, apply for, obtain or transfer a working interest or initial separation of overriding royalty interest in an oil and gas, gas only, or geothermal lease or exploration license, or permit

When do qualifications need to be updated?

An entity is only qualified for the current calendar year. Each year, any entity that holds an interest or plans to obtain an interest in an oil and gas lease, gas only lease, or exploration license, or permit must update their qualifications by February 15 of each year. (11 AAC 82.205(g)) Use the form included with this packet for annual qualification updates.

How can I tell if my qualifications are up to date?

The Division publishes an updated qualifications report each Monday. The report is located [here](#). Should you find a discrepancy with your qualification information or if you have submitted qualifications updates which are not reflected on the most recent report, please send us an email at dog.qualifications@alaska.gov and we will respond to you within two business days.

INSTRUCTIONS

How do I qualify my entity (11 AAC 82.200 and 11 AAC 82.205)?

Submit all of the required information, as outlined in these instructions, to the Division in one packet if possible. Any omissions in the required information should be noted in a cover letter with a date of anticipated submission. The Division will begin the verification process once all documents have been received and will request additional information from the applicant as necessary. When the process is complete, the Division will contact the applicant via email and provide the qualification number.

All business entities must submit:

(1) a completed copy of the attached Business Contact Information and Authorized Signors form. (International entities that do not have an office in the United States will need to use the registered agent, as listed on the State of Alaska Department of Commerce, Community, and Economic Development website, as their primary mailing address for Division of Oil and Gas qualification and notification purposes.)

(2) if your entity is currently qualified to do business in Alaska through the DCCED, please submit a certificate of compliance for the current calendar year.

If your entity is being registered with DCCED for the first time as part of this process, please submit either of the following documents obtained through DCCED:

- (a) a certificate of authority for a foreign corporation qualified to do business in Alaska, OR
- (b) a certificate of incorporation for a domestic corporation qualified to do business in Alaska.

(3) an original or certified copy of a notarized power of attorney authorizing any agent who is not a current officer but who has been authorized by the entity to act on its behalf with respect to the permit, oil and gas exploration license, or lease. **Note: This form may not be used in place of power of attorney documentation.**

Partnerships, Joint Ventures, Limited Partnerships, LLCs or other incorporated associations are required to submit the items listed in numbers 1 through 3 as well as a statement describing the business relationship between the members of the association, joint venture, or partnership.

How and where do I submit my qualification documents?

With the exception of any notarized documents including powers of attorney, which must be original or original certified copies of notarized documents, qualification documents are acceptable in electronic form. Documents may be e-mailed, mailed, or hand-delivered to:

Processing of qualifications will not begin until all documents have been received by the Division. Once processing is complete, a confirmation email will be sent to the email address provided on this form.

What do I do now that I am qualified?

The qualification number is required on all lease sale bid forms and all assignment forms. Remember, your qualifications must be updated annually.
